

Rector's Report

Dear friends,

I am honoured once again to present to you this annual report outlining the work and witness of St. Paul's Church in 2020. This Annual Report will certainly be unlike any other in the history of our parish. Words like 'unprecedented' have been greatly overused over the past year, but not without good reason. The COVID-19 pandemic and the necessary restrictions have impacted all aspects of our lives – including our common life at St. Paul's.

I have said many times over the past year that although our church building was closed, the Church has always been very much open. From the outside, it may seem like things have been quiet around St. Paul's. In one way that's true. Numbers at worship have been down (when we could meet at all), staff was often working off-site, and many of the big annual events didn't take place. However, I would propose to you that this past year has nonetheless been one of tremendous vitality for St. Paul's.


I have been heartened by the many 'acts of kindness' I have heard about this year. Parishioners have been reaching out to one another by phone and email, checking on one another and lending a listening ear. Others have been running errands or cooking meals for those who are shut-in, sick, or who are isolating. I believe we have been even more in tune to the needs of our neighbours. In our attentiveness to one another, we have been putting our faith into action. This past year has been difficult for many of us. On a personal level, this past year held numerous challenges for Erin and I. I would like to, in particular, thank the many parishioners who reached out with sympathy and support upon the passing of my dear grandmother in Newfoundland. Your kindness was deeply touching.

St. Paul's has also been strong in our ministry of hospitality. This year we welcomed Mansour, our sponsored Syrian refugee, to Canada. Your generosity of spirit has been life-changing for him. You stepped up and have shown him what it means to be a Canadian, and more importantly what it means to be part of the one body of Christ. Mansour has adapted very well to life in Canada and plans to settle long-term in the Saint John area. This year we were also pleased to welcome into our midst the congregation of Mission Church. As a result of the COVID-19 restrictions, they ceded their worship space at Outflow Shelter so that the men would be able to properly distance. They now worship at St. Paul's each Sunday at 12:15 p.m. We look forward to building ties of friendship and working together in God's mission. I am grateful for the warm welcome you have all shown to them.

This year has also been one of learning. In March, with the help and expertise of staff and volunteers, we were able to very quickly shift to offering worship online. Not only have we maintained a weekly livestream, but we have learned how to use tools like Zoom in order to carry out the business of Vestry and the various committees. We have continued to grow in our faith through online Bible studies, Alpha, and Book Club. Our website and Facebook page have been updated nearly daily and an email newsletter has gone out to our contact list weekly. Our Child & Youth page has also been updated regularly with videos and resources for at-home Sunday School lessons. These have been a lifeline for so many of us as we attempt to stay connected with one another in a physically distanced world.

Our After School Program has remained a strong ministry of our parish. This past year we were pleased to hire two familiar faces to lead our program. Leah Doiron was hired as ASP Director and Hannah McEvoy was hired as ASP Assistant.

As you will read in this report, all of our groups and committees have found new and creative ways to carry out their work and mission and they are to be commended. We continued to reach out to our own flock and beyond with hope and help. One such example of this innovative approach was our Sounds for





Sigowet concert. Instead of canceling, our Mission Beyond Committee, volunteers, staff members, and local musicians, rallied together and planned an online concert. This was a huge success and allowed people from around the world, including Kenya, to join us at St. Paul's!

I cannot pass up this opportunity to thank our parish staff: Pastor Jeremy McNally, Spring Lake, Charles Willett, Leah Doiron, Hannah McEvoy, Peter Irish, Ted Sayre, Rev'd Eileen Irish, Fr. Stuart Allan and Fr. Jim Golding. Each of them rose to the occasion and have empowered and enabled the ministry of St. Paul's to continue in spite of the constant shifting of rules and regulations. I would also like to highlight the key roles played last year by members of our Altar Guild, Lay Readers, as well as our organist and cantors – Madeline Boutilier and Robert Taylor. I am also very grateful for the guidance and expertise of Jeff Porter, who has contributed greatly to our livestreaming ministry.

At a time like this, it would be all too easy for us to give up and let our connection to the church and one another go by the wayside. It has been really encouraging for me to see how so many of you have persisted, in spite of everything, and remained connected. In many ways, this crisis has served to make us stronger disciples. It has taken real effort and commitment to persevere in nourishing and growing our faith. I do believe that on the other side of all of this we will emerge as stronger and more enthusiastic disciples of Jesus Christ.

Finally, thank you to all those who worked hard to bring together this annual report of our life and work. Praise God for his faithfulness and for all he has done in and through us!

Wardens' Report

It is our honour to look back at 2020 and reflect with you on how God's continuous blessing and strength carried St. Paul's and each of us through what was an unsettling year.

The impact of the Covid-19 Pandemic globally compelled us individually and collectively as a parish to move in unprecedented directions. Together, with God's help, we faced many challenges including the loss of loved ones, the care and concern for the health of our loved ones, the loss of not being with our church family and the loss of not seeing each other's loving and welcoming smile.

Many aspects of parish life have temporarily changed, not just at St. Paul's but throughout the Anglican faith and with all faiths. The impact has caused change in how we are able to welcome people, how we are able to express our faith through liturgy and how we are able to support mission. But despite it all, with Fr. Paul's exemplary leadership, we have carried on. We have continued to worship together, whether it be on-line or with limited capacity in church and we are thankful to Charles Willet and the music ministry contributors who continue to enhance our beautiful worship services. With the support of a great team providing much needed technical support, we have easily transitioned to on-line Bible studies, Book Clubs, Youth Group, various committee meetings and have shared many wonderful services such as the Lessons and Carols service. We also welcomed newcomers to God's family in the past year through several Baptisms.

In 2019 Fr. Paul introduced the idea of St. Paul's collaborating with Our Lady of Perpetual Help in supporting a Syrian Refugee named Mansour Najjar. In February, 2020, Mansour arrived and quickly settled in, warming our hearts with his smile and sincere gratitude. From the beginning there were many volunteers who worked with Fr. Paul to make all the necessary arrangements and meet the financial obligations to ensure his arrival. The final fund-raiser was a take-out Indian dinner held in the Fall. Although the monthly financial commitment is now finished, we will continue to welcome Mansour as a member of our parish family.

The immeasurable generosity of the parish family of St. Paul's was once again expressed in many ways in 2020 through Stewardship; the selfless giving of Time, Treasures and Talents. The Mission of St. Paul's remains as a commitment to Christian Discipleship by supporting the on-going work of the church here and abroad, supporting those in need and supporting each other. A few examples of the parish's continued commitment to supporting the Mission of the Church were: the various fund-raising initiatives including the annual Sigowet Concert which was held on-line and the Bun-wich Sundays. Other mission projects included the making and distribution of Prayer Shawls, the donation of clothing, food, and other items to those in need locally and the many financial donations to charities local and abroad. In 2020 we also welcomed the Mission Church congregation and Fr. Stuart Allan to use our church and facilities as they needed church.

The strong sense of family and community exists because of the people of St. Paul's. There are many to acknowledge and thank for their continued leadership and dedication including the honorary clergy: Rev. Eileen Irish, Rev. Jim Golding, and Rev. Stuart Allan. We are also grateful for our staff members including Pastor Jeremy McNally (Youth & Family Minster), Peter Irish (Bookkeeper), Spring Lake (Sexton & Secretary), Ted Sayre (Property) and Leah Doiron and Hannah McEvoy (After School Program). It is also essential to acknowledge and thank our many dedicated volunteers that richly contribute to the parish in various and not always obvious ways and are deeply committed to God's work through supporting worship, music, Sunday School, Youth Group, greeters, coffee hour, meal preparations, altar preparations, offering counters, readers, technical support, funeral reception preparation, grounds,



property, and finances. As outlined in this report, we are richly blessed for their many accomplishments this past year.

We are also grateful to our dedicated Treasurer, Robert Taylor, the chairperson of the Finance Committee, Stephen Palmer, and the members of Vestry that serve in a committed leadership role supporting Fr. Paul and the parish. We recognize and thank for their service those who will be stepping down: Stephen Palmer and Keith Dow. Due to Deb Godlewski taking a short break as Warden because of work requirements, we are thankful Pam lype stepped in as interim Warden.

It is with genuine gratitude that we together thank Fr. Paul and his wife Erin, who have shown faithful devotion to God's work at St. Paul's with resilience and determination. Fr. Paul faced in 2020 and continues to face in 2021, the exceedingly difficult job of over-seeing the running of the parish during particularly challenging times. He too had to quickly adapt to change as required by the various government departments and by the Diocese but did so with grace and courage. His acceptance of difficulties and seeing them as preparation for abundant blessings, rather than resenting them, has been an inspiration of how we too can live above our circumstances even while we are in the midst of them.

Although in 2020 world developments impacted St. Paul's financially, the parish qualified to receive financial aid through government assistance and Identifiable Giving saw an increase in e-offering givers which helped to weaken the impact. As we continue to wade through the uncertainty of the upcoming months in 2021, we will remain committed to the close watch of the parish finances by monitoring income and spending and will continue to provide updates to the parish.

Repeatedly in 2020 we were reminded of the depth of God's love and mercy. As we continue to pray together in 2021 and seek God's direction for our lives and for St. Paul's, He will continue to prepare us for each day, transforming our fear into confident trust in Him.

Treasurer's Report

March 2020 brought a sinking, almost sick feeling to the stomachs of everyone who had rents and loans to pay, everyone who was invested in equities, and everyone who was responsible to plan and monitor budgets and pay employees and monthly bills. Our own Finance Committee, under the capable chairmanship of Steve Palmer and the meticulous bookkeeping of Peter Irish, wondered what disaster might await us by year's end.

As it turns out, what you will read in the following pages and hear from Steve in our Annual Meeting had only one disastrous element – that came in March when we had to close down our After School Program and refund over \$25,000 in fees. On the Operations side, we count ourselves fortunate indeed to have loyal parishioners who kept up their offerings level to 92% of what it was in 2019 and 97% of what it was in 2018. Over 40% of those offerings come in through e-offering, which generates a predictable revenue in the leaner months. But it was the several months of Wage Subsidies that we received, totalling over \$53,000, that was the biggest help in turning a combined deficit of nearly \$9000 (approved at last year's Annual Meeting) into a combined surplus of nearly \$39,000. Without any Wage Subsidies, our combined deficit would have been about \$14,000. We recognize also the assistance of the Diocese, which cancelled the Shared Ministry allotment for all Parishes during March, and has reduced 2021 allotments by 5%.

The unexpected good news of 2020 is balanced by some cautions for 2021. Firstly, the Finance Committee has kept to its recent practice of budgeting Identifiable Giving at the same level as it ended up at in 2019 – always in hopes of doing better. Secondly, we have budgeted no income from the Wage Subsidy. Even though that program continues until June 2021, what we receive in any month is predicated upon our offerings coming in lower than the same month the year before. Assuming no further lockdown happens, we do not predict that this will occur. With these points in mind, you will notice that the Finance Committee and Vestry are putting forth a deficit budget for your consideration. We are recommending a two-year averaging whereby the surplus of \$39,000 achieved in 2020 serves as a cushion for the anticipated deficit of about \$26,000 in 2021. Like everything in these days of COVID, the budget will be a "living document", to be monitored regularly. Your support will as always be greatly appreciated.







Vestry Committee Reports

Syrian Sponsorship End of Project Report

We at St. Paul's Anglican Church entered into a contract with Immigration Canada in 2018 to privately sponsor Mansour Najar to immigrate to Canada from Lebanon. Mansour is a Syrian who fled from Syria and was living in Lebanon. Fr. Paul had been in touch with Mansour and we embraced the idea of helping him to get over to Canada. This was facilitated through a sponsorship opportunity which Our Lady of Perpetual Help had been allocated by Immigration Canada. The terms of the agreement included the responsibility of St. Paul's to take on organising, overseeing and supporting both financially and administratively Mansour's immigration for one year commencing upon his arrival in Canada (Saint John). We had to have a minimum of \$15,000. This contract was authorised by St. Paul's Vestry and Mission Beyond the Parish has been the sponsoring committee.

The Syrian Sponsorship/Support Committee which included members of our parish and the community at large was set up to practically handle all matters pertaining to Mansour's immigration. Originally, five volunteers started the ball rolling. They recruited volunteers with many skills who provided a pool of resources to be involved and called upon when necessary. Plans were made, applications submitted, a budget was established and fundraising commenced.


Mansour arrived on February 10, 2020. Initially he was hosted by Fr. Paul and Erin. He moved into an apartment on Queen Square in Saint John beginning of March. The apartment was fully furnished by donations from members of St. Paul's congregation. All his immediate needs were assessed and provided for. He spent a few months acclimatising and familiarising himself with life in Canada, while he put together his resume and was seeking employment opportunities. He was able to obtain some limited casual work (yard work, house painting) through various members of St. Paul's. He attended services at St. Paul's and has done considerable volunteer work at the church.

In August of 2020, Mansour was fortunate to find a temporary job doing shift work on the assembly line at Crosby's Molasses plant on Rothesay Avenue. He has fitted in and has done his job well that he has been advised that his employment would continue into 2021. He is contemplating on taking a driving course at NBCC which would equip him to apply for a job driving commercial trucks. He has saved enough money to buy himself a used car which will be an asset in Saint John.

According to the contractual obligations, Mansour has been receiving monthly support cheques from St. Paul's beginning March 2020 until February 2021. Fr. Paul and Erin hosted him at their home till the end of February, 2020. The last payment will be at the end of January 2021 to cover his expenses in February. At the end of this period, whatever amount is left in the account will be paid to him.

This project has run successfully and is coming to a conclusion on time and within budget. Barring some unforeseen circumstance, St. Paul's will have met its contractual obligations to Mansour effective February 28, 2021.





Mansour has settled in well and is happy. This would not have happened without Our Lady of Perpetual Help offering us the spot that was available to them. Thank you, Leticia Adair for sharing your knowledge with us. Thanks to all those who very generously gave their time, expertise, funds, donations of household items and support. Many who are not members of St. Paul's, who served on the Mansour Support Committee, thank you. Most importantly, our sincere thanks go out to Fr. Paul for bringing Mansour to our attention, giving us help and guidance along the way.

We are thankful to God for giving us the opportunity to bring Mansour to this peaceful country so that he may lead a safe and productive life.

St. Paul's Endowment Fund Report

St. Paul's Endowment Fund was established in 1999 and is intended to be a vehicle by which parishioners of St. Paul's and others can make contributions that will support the work of the church in an on-going way. Interest earned on the capital of the fund and up to 5% of the capital may be distributed annually. Applications for funding are made by church groups and committees as well as groups outside of the parish.

Currently, the members of the Endowment Fund Committee are Jon LeHeup (chair), Peter Graham, Bruce Cook, Albert Fraser, and Fr. Paul Rideout. This year we were pleased to welcome Jon to the committee. He has also agreed to chair the group. We would also like to recognize and thank Gerry McCracken for his contributions to the committee over many years of faithful service.

As of the November 18th, 2020 the Endowment Fund balance was \$308,558.37. This is invested with the Diocese of Fredericton. As of November 18th, 2020, total interest available for distribution was \$18,838.85. According to the terms of the trust, this amount was divided equally to support four categories of applications.

Funds were distributed to support the following:

Category A: Building Projects at St. Paul's

Painting of St. Paul's exterior

Category B: Spiritual Life of the Parish

- 1. Replacement piano for the church
- 2. Musicians for Christmas Lessons & Carols

Category C: Families in need and worthy projects in the Saint John area

Child & Youth Minister's Report

Changes due to COVID19...a year like no other

Last year at this time most of us had never heard of Coronavirus, but since that time all of our lives have been impacted by it. For me, as a minister of the Gospel, it has meant a monthly or sometimes weekly adjustment of approaches to ministry. Flexibility has been key this year.

For starters, in March when none of us knew how contagious COVID19 was, we did what everyone did in other churches and halted all in-person ministry. Some churches have barely resumed in-person ministry since this time, including Sunday services. To me St. Paul's has stood out for the creative and dedicated application of new remote forms of ministry. I believe Fr. Paul merits special recognition for his leadership through this uncertain time.

A highlight in this time was how seamlessly Discovery Bible Study and Alpha moved to the online format. To my recollection we never missed a week. Nor did we miss a week with our Sunday Services, except one or two due to technical glitches. This was all accomplished with a minimum outlay of cash, but a lot of time and effort throughout the year.

Tech Ministry


So a new ministry was born at St. Paul's, the "Tech Ministry". Jeff Porter is one without whom this couldn't have launched as seamlessly as it did. We now have a dedicated and trained group of volunteers weekly running this essential ministry. Special thanks also to Ted Sayre who did a lot of behind the scenes work and the rest of our Tech Team Sherry Hounsell, Paul Taylor and Hadley Wood. Two events that were notably streamed this year were Sounds for Sigowet and the music for Lessons & Carols. Sounds for Sigowet was live recorded and the music for Lessons & Carols was pre-recorded. Apparently both of these events were well received in spite of people's preference to meet in person.

Children & Youth

Youth and children's ministry have been difficult during this pandemic. As so much fun presentation and personal relationship is needed for effective ministry with young people. In this arena online ministry has shown its limitations. However after halting Sunday school and in-person youth group in March, online youth group was launched and at-home Sunday school activities were posted on our website. With summer and fall, and the introduction of yellow phase, in-person activities were on again, with social distancing and masks of course. The youth began to meet again and a Sunday school kickoff event happened. These were all well received but attendance remained low for Sunday school. The impression I've gotten from the parents of younger children is that they aren't planning to return to inperson attendance until the effective end of the pandemic. In speaking with other church leaders in our area and beyond, I would say we are all facing similar challenges.

Thank you to our Sunday school and Youth group volunteers without who we wouldn't be able to meet: Linda McAvoy, Ann Bishop, Mina McNally, Spring Lake, Mansour Najjar and Pam lype.

The After School Program (ASP) children's ministry however has been going well despite the new restrictions. The advent of two new TV's in the ASP area has increased ministry effectiveness greatly.





Even though we cannot sing, songs and video streamed through the TV's have been very well received. This is a bright spot of outreach and faith formation in our community.

The launch of our proposed Study Hall, which would've provided a welcome place of quiet study complete with free internet, drinks and snacks for High Schoolers in our community, has been postponed due to yo-yoing in and out of Orange Phase. Thanks to volunteers who have been willing to help with this, Cassie Stanley and Mildred Urquhart.

This year our 4:00 Family Christmas Service was well attended despite us not being able to do our usual Live Nativity performance. This was encouraging to see.

A Personal Note

On a personal note I wish to thank all those who supported me during my father's untimely passing from cancer this past May. I also wish to thank all those who generously sent cards and gifts at Christmas. St. Paul's remains for me a great place to work and this is mainly owed to my daily co-workers Fr. Paul and Spring Lake. Both are a pleasure to work with and for. The office at St. Paul's is pervaded by a servant-hearted spirit of help and regard for one another that is both God-honouring and a delight to be a part of.

Mission Beyond the Parish Chairperson's Report

Annual Report of The Mission Beyond the Parish Committee St. Paul's Church 2020

This past year has presented a challenge for MBTP as it has for just about everyone. The year began under normal circumstances seeing us send funds raised to The Sigowet School for student sponsorships. A total of \$16,000 was raised for this purpose. This money came from The Sounds for Sigowet Concert and silent auction, the sale of jams and preserves and from your generous donations to the cause.

Our Pancake Supper was held in February. Money from this came to our committee and \$942.08 was donated through a good will offering. Not long after this we had to adjust our ways due to the arrival of Covid-19 in our province. Realizing that the need, and perhaps an even greater need, was still out there we had to carry on in some way. We have been meeting monthly via Zoom with thanks to Gus Bonnycastle for hosting the meetings. Although not all our members are able to attend in this way we have been able to have a quorum at most meetings.

We were unable to hold our annual Giant Yard Sale which is a major fundraiser for us.

Using technology and innovation we were able to present our Sounds for Sigowet Concert on line. We have many people to thank for making this happen, especially our musicians and tech crew. Through the concert and other donations, a grant from the Endowment Fund and jam and preserve sales we have a balance of over \$10,000 towards 2021 sponsorships. Many thanks to Christian Turnbull for her work bottling jams and preserves.

The partnership with the Rothesay High School Breakfast program continues although, due to Covid restrictions, in a somewhat different manner. Thanks to Gayle Johnston for keeping this going. Thanks to our parishioners for their support for this project. In addition to the breakfast program we have also been providing sandwiches for students in need of a lunch. Thanks again to Gayle for making and delivering the sandwiches to the school.

MBTP has been the hosting committee in bringing Mansour to Canada and supporting him although the hands on work has been done by a sub-committee headed by Pam lype. This has been a true success story and we owe a great deal of gratitude to all those who have made this a reality.

During the past year we have made donations in total of \$9,700 to the following organizations; Inner City Youth Ministry, KV Food Bank, Outflow Ministries, Hestia House, PWRDF, Romero House, Pennies and Sparrows (the Chandra Ministry), St. Luke's Breakfast Program, Elizabeth Fry Society, Harbour Lights and The Kennebecasis Fire Department. We will continue to recognize both our local and greater community as we go forward.



I want to thank, on behalf of the committee, both Father Paul and Jeremy who have been a great support. I also want to say a special thank you to Spring Lake for all she does for us. She has been a great help in many ways. And lastly thanks to you the members of St. Paul's who give so generously of your time and treasure. God bless you all.

Property Committee

Due to the COVID-19 virus, no major projects were carried out at St. Paul's in 2020. 2019 was also a light year for church project work due to the extended period of road construction on Church Avenue.

2020 Property Expenses:

The overall 2020 property maintenance cost was \$4227 below budget due mainly to (i) COVID-driven postponement in exterior painting work and (ii) savings on snow removal as a result of changing the snow removal contractor.

Key points:

- 1) Exterior painting of the church sanctuary "triangle" area above the front columns, clock tower and steeple base, including temporary power line relocation, were quoted. COVID-permitting, this will be the major project of 2021.
 - Painting will cost \$15,000 plus cost for replacement of any rotten wood (TBD).



- Temporary power line relocation by NB Power will cost \$3500. Use of a lift machine for painting access requires power be disconnected and service re-routed.
- Staging will be quoted in Q1 2021 as a potential alternative to the lift machine.
- 2) The sanctuary front doors were stripped and four coats of high quality marine spar varnish were applied. They'll require a light sanding and one new coat every 2-3 years.
- 3) The two wooden benches (courtyard and sidewalk) were refinished by Jane Smith. St. Paul's would like to thank Ann and Jane for all their hard work in the garden to beautify the exterior of St. Paul's!
- 4) The exterior stairs to the hall kitchen were stripped, sanded and painted by the Crawford family. Thanks Crawfords!
- 5) Ted Sayre looked after ongoing maintenance throughout the year.
- 6) Ted and Beth Sayre took over the snow clearing contract mid-year, saving St. Paul's a significant amount of money vs. the contractor we had been using, as noted above. Thanks Ted and Beth!

The property committee wishes to thank all parishioners who donate their time and skill to the upkeep and improvement of our beautiful church property.

Safe Church Report

The Safe Church Committee members, Enid Haley, Keith Dow, Spring Lake and Pam Iype have not met in person since March 2020. We have made sure the mandate of the Diocesan Safe Church regulations have been carried out. The pandemic started in March and that brought about changes as to how we meet, worship, and socialise at church.

Fr. Paul has encouraged a very strict protocol mandated by the Government regulations for everyone to follow not only during Sunday services but also whenever people entered or exited the building. Pews are marked as to where one can sit. They are cleaned after every service. There is a mask mandate and during the Orange phase, singing is eliminated. There have been no social gatherings. All committee meetings are held virtually.

Hand sanitizing and maintaining 2 m distance have been promoted.

Mission Church is having their services at St. Paul's. They have been appraised of the Safe Church regulations that we have in place.

A checklist has been drawn to facilitate monthly and yearly checks of everything under Safe Church.

All in leadership roles in the Parish (staff, clergy, vestry, chairs of committees and all those who work with vulnerable people) should have Police and Vulnerability checks done that have to be renewed every three years. There will be a list at the office to make sure everyone listed has an up to date Police checks. They are being done by the Police Department on line and following is the link for it: http://www.policesolutions.ca/checks/services/kennebecasis/index.php

The Diocesan Privacy Policies are to be upheld at all times. The Committee has written a few policies for the people who handle any information of personal and sensitive nature.

- The defibrillator gets checked every month and a log is maintained.
- There are two First Aid kits, one in the kitchen and the other in the office.
- A digital thermometer has been purchased.
- Sanitizing and disinfecting cleaners are used in the church and in the kitchen.

Our thanks go out to Fr. Paul for taking the leadership role in maintaining safety in the premises with the protocols during the pandemic. Thanks to the members for their commitment.

Communications Committee Report

Here are some of our areas of focus over the past year:

- 1. *Email list*. With the onset of the COVID-19 restrictions, we put a push on to bring together numerous small email lists into one parish-wide list. This way, we were able to communicate more easily with a large swathe of our parishioners. We have evolved from sending periodic emails to sending weekly e-newsletters. From time to time We currently have nearly 200 parishioners on our email list.
- 2. Website. The website received a makeover last year in an attempt to keep things fresh, accessible, and visually appealing. The website became an important way to get out vital information as provincial regulations changed on a near daily basis. Our website has also been a useful tool to facilitate sign-ups for worship. We also ran a successful feature asking parishioners to share some good news of God's blessings. Our website had 10,100 visits in 2020.
- 3. *St. Paul's Logo*. Our new logo and name were launched at our AGM in 2020. This fresh new look incorporates the green of the Rothesay Common and the profile of our spire. The bringing together of the church and the public square encapsulates our mission to be a church who is active outside of our doors.
- 4. *Facebook.* Marilyn Duplacey has kept our Facebook page up-to-date, recognizing that it is an important line of communication with 328 followers and growing.
- 5. Worship Livestream. The Sunday livestream continues to be an essential part of our new mode of operation at St. Paul's. Jeff Porter and Pastor Jeremy have been key to the technical side of the process. Each week we are averaging 80 views, with spikes of up to 600 for special services. We have also been able to offer this ministry to grieving families so loved ones unable to travel can participate in the funeral. This ministry has proven to be a valuable means of providing spiritual nourishment to our own congregation as well as to those beyond the bounds of our parish. Pastor Jeremy has developed a small but faithful rota of volunteers who run the audio/video each week.
- 6. Online Meetings. Although not initiated by the committee, it is worth noting here that nearly all committees and groups within our parish have employed Zoom as a means of meeting during the pandemic.
- 7. *Letters.* Letters were distributed to the Parish at Easter and Advent. In addition, letters were sent regularly to the sick and shut-ins.
- 8. *Phone Ministry*. There was a very active, albeit informal, phone call ministry amongst parishioners and parish clergy.

The current members of the committee are: Fr. Paul, Pastor Jeremy, Greg Fleet, Paul Taylor, and Jeff Porter. We are always happy to welcome anyone who has a gift and passion for this area of ministry.
